Here’s to a Happy 2020!!!

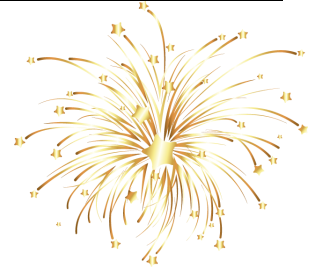


See how many words you can make with the letters in:
