

So long 2022! 2023 is promising to be Great!

To date we have COVID tested residents 10,189 times with 48 positives and tested staff 23,025 times with 108 positives. Our vaccination statistics are as follows:

- Residents who completed the primary vaccination series - 95.7% with a state average of 86%
- Residents who are up to date with their vaccines - 84.3% with state average of 42.6%
- Staff who completed the primary vaccination series - 86.8% with a state average of 86.5%
- Staff who are up to date on their vaccines - 17.9% with a state average of 14.7%

Obviously, the current facts are; COVID is still with us and our vigilance must continue to keep Oakview residents and staff safe!

We love seeing visitors in the building. Thank you for continuing to wear your masks and to screen in and out on Accushield.

We are looking forward to 2023 and all the hope a new year brings.
