Resident Right

Every month, we will include one of the Resident Rights or Responsibilities as written in Oakview's "Residents Rights and Responsibilities" Policy. We want our residents and their families to know these important Resident Rights and Responsibilities. If you should have any questions about any of these, please don't hesitate to ask.

G. Information and Communication

(4) The resident has the right to receive notices orally (meaning spoken) and in writing (including Braille) in a format and language he or she understands, including;

- (i) Required notices as specified in this section. The facility must furnish to each resident a written description of legal rights which includes
 - (A) A description of the manner or protecting personal funds, under paragraph (f)(10) of this section.
